# a. Discuss and approve library policy page 12 - Action Item

Trustee Wegener made moved to insert under Collection Management" on the last line after the word "format" – "All titles in the Cascade Public Library and the LiLi Database collections will comply with Sections 33-2508, 33-137, and 18-1514 of Idaho Code to ensure that no materials harmful to minors, as defined in Idaho Code, are available." 2<sup>nd</sup> by Trustee Buckmaster. Motion carried.

## b. Discuss and recommend new board application. Action Item

 A motion to recommend Brad Welker as a new Trustee member was made by Chairman Butterfield, 2<sup>nd</sup> by Trustee Buckmaster. Motion carried. Mr. Welker's application will be forwarded to Cascade City Council for approval. Mr. Welker will fill the vacant position previously held by Trustee Reinhardt. The term expires 12/31/25.
